strongly urged to review the requirements as detailed in the solicitation documents. Submittals that are not completed accordingly, will not be considered. See attachment #2 in the solicitation documents.

- 3. All offers must hold their pricing as submitted for 60 days.
- 4. If there are conflicts in the bid documents, the most stringent applies.
- 5. The facility will remain open for business during construction.
- 6. The contractor is required to maintain a safe working environment for both the USPS employees as well as the public.
- 7. The successful bidder will be required to provide a site-specific safety plan within 10 days of contract award.
- 8. Natalie addressed all bidding expectations, rules and requirements as detailed in the solicitation documents. No exceptions were noted.
- 9. Both Tim M and Natalie S. expressed the need to complete the project within the allotted time frame detailed per solicitation.
- 10. Under clause B-15, any delays should immediately be communicated to the contracting officer in writing to ensure full consideration of the facts and circumstances. We understand there are unforeseen conditions which may affect performance and are beyond the contractor or subcontractor's control, however, there will be no time extensions granted simply because the contractor does not effectively manage the project.
- 11. This project carries liquidated damages per Clause 2-10. These will be assessed when there are delays in the performance that are due to the fault or negligence of the contractor or their subs. These aren't intended to be punitive; they are a fair representation of anticipated costs from additional AE construction oversight and operational losses that are a direct result from delays in performance.
