<u>Please review Statement of Work Below which supersedes the IRA scope in all sections of the RFP document.</u>

Inflation Reduction Act (IRA) Funded Scope of Work

The general scope of the **NGDV** funded work includes modifications to all areas associated with the layout and charging of the new NGDV.

1. NGDV Electrical Scope of Work

All electric chargers mentioned in the below scope will be Owner Furnished and Contractor Installed

- a) Electric Vehicle Chargers (2) 2 Rexel USA Inc/ChargePoint CP6011B-80A-L7 single port, pedestal mounted, 19.2kW chargers with a 23' cable length. Electrical Vehicle Supply Equipment (EVSE) USPS Kit Number CP001. Chargers will be placed as shown on the C200 Proposed Conditions drawing.
- **b)** Contractor to provide bollards per plan and each parking space, will have a 6-inch concrete wheel stop furnished and installed by contractor.

2. Electrical Upgrades for Charger Installation The below two items a) and b) are Contractor Furnished and Contractor Installed.

- a. New Transformer two (2) new single-phase 25KVA 480V/240 transformers. Contractor to furnish and install.
- b. New Dedicated Electric Panels two (2) new dedicated panels will be installed on the north side of the Vehicle Maintenance Facility (VMF) in the parking lot. *Contractor to furnish and install.*
